## Leaders in Life Sciences - Privacy and Cookie Statement

#### Introduction

Leaders in Life Sciences is a brand name of Pivot Park Samenwerkingen B.V. which is a company based in the Netherlands. When you use our website <a href="www.leadersinlifesciences.nl">www.leadersinlifesciences.nl</a> and/or listen to our podcast, it is possible that your personal data as referred to in the General Data Protection Regulation ('GDPR') will be processed. As controller, we are responsible for handling all personal data with care, so we comply with all requirements imposed by privacy legislation. This means that we only process your personal data when it is necessary and lawful. It is no obligation to share personal data with us, but without providing us the data as stated in this privacy statement, you may not be able to use our services properly.

As required by the GDPR, we inform you about the handling of your personal data in the form of this Privacy and Cookie Statement. In this statement we summarize when and how your personal data is collected, used, secured and disclosed by us.

#### General

We may change the provisions of this statement if needed. If these changes are impactful, we will inform you by email (if your email address is known to us). Nevertheless, we advise you to check on a regular basis whether this statement has been changed. The last change was in February 2025.

# Which personal data do we collect, on what grounds and how long do we retain this data?

When you <u>browse and/or watch podcasts on our website</u>, we process the following personal data from you:

- IP address
- location
- operating system (such as iOS or Android)
- identifiers in cookies

We collect this data based on our legitimate interest. We use this data to improve our website. This personal data is directly collected by us. We retain this data for 2 years.

### Storage and transferring of personal data

Most of our data is stored on servers in the European Economic Area (EEA). We transfer the data you provided to third parties if this is necessary for the provision of the requested services, if you have given your prior consent or if we are legally obliged to do so.

#### Third party websites or apps

If you listen to the podcast using a third-party website or app like Spotify, Google Podcasts or Apple Podcast the privacy statement of the third party also applies. We have no control over these websites and apps or their activities. If you provide personal data to third parties, we are not involved. We advise you to study their privacy and security practices and their statement before you provide personal data to them.

#### Protection of personal data

We take appropriate technical and organizational security measures for the protection of your personal data. We follow generally accepted standards for this protection. We would like to

point out that absolute security for transmitting personal data over the internet, or for storing personal data, cannot be guaranteed. We have taken the following measures:

- SSL (Secure Socket Layer) technology to encrypt the transmission of sensitive information or personal data;
- Back-ups of personal data are made if reasonably possible.

#### Cookies

Our website uses cookies and other related technologies such as scripts and web beacons (for convenience all technologies are referred to as "cookies"). A cookie is a small simple file that is sent along with pages of this website and stored by your browser on the hard drive of your computer or another device. The information stored therein may be returned to our servers or to the servers of the relevant third parties during a subsequent visit. A distinction can be made between the three types of cookies: functional cookies, analytical cookies and marketing or tracking cookies. This website does not use marketing cookies.

We use cookies to distinguish one user from the other. This helps us to provide you with a good experience when you browse our website and it allows us to improve the website. When you visit our website for the first time, you will see a pop-up explaining cookies. As soon as you click on "Accept" or "Save preferences", you give us permission to use the categories of cookies and plug-ins you selected in the pop-up. You can disable the use of cookies via your browser, but please note that our website may no longer work properly. You can also use your internet browser to delete cookies automatically or manually. You can also specify that certain cookies should not be placed. For more information about these options, please refer to the instructions in the Help section of your browser. If you do delete the cookies in your browser, they will be placed again after your consent when you visit our website again.

#### Your rights

You have the right to access, correct, transfer and/or delete the personal data collected by us. In some cases you can also request us to temporarily restrict the processing of your personal data or object to the processing of your data in the future. These rights are not absolute, sometimes we have the right to store your personal data. For example for dispute resolution, enforcement of applicable terms of use, technical and/or legal requirements.

We do not process any personal data on the basis of consent, nor do we use automated decision making.

If you would like to exercise any of your rights, please contact us using the contact details as stated below. Please note that the consequence of removal of personal data, restriction of the processing or withdrawal of permission may be that you can no longer (properly) use our services.

In order to access your own personal data by e-mail, we may ask you to provide sufficient evidence of your identity. If we are not sure whether you are the actual person to whom the personal data relates, we can deny you access to the personal data. We will respond to all your requests within 4 weeks. For complex requests, this period can be extended by 4 weeks. If we do extend this period, we will notify you within 4 weeks after you submitted your request.

You also have the right to submit a complaint to the authorized privacy authority regarding the way we handle your personal data. In the Netherlands this is the Dutch Data Protection

Authority (*Autoriteit Persoonsgegevens*), which you can reach at https://autoriteitpersoonsgegevens.nl/.
